- The arrangements and installation of the lights on survival crafts are not part of this design appraisal or certificate and are to be to the satisfaction of the Surveyors attending on board
- If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply
- Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or Product Verification (Module F) of the Marine Equipment Directive
- Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), or Product Quality Assurance (Module E), or Product Verification (Module F) of the Marine Equipment Directive.
